FINAL JUDGMENT

This case was called to trial on March 2, 2020. Plaintiff Emergency Staffing Solutions, Inc. (“Plaintiff”) appeared through its counsel and corporate representative and announced ready for trial. Defendants Jellico Community Hospital, Inc. d/b/a Jellico Community Hospital Health, LLC (“Jellico”) and Community Hospital Corporation (“CHC”) (Jellico and CHC are collectively referred to herein as “Defendants”) appeared through their counsel and corporate representatives and announced ready for trial. After all parties announced ready, the Court determined that it had jurisdiction over the subject matter and the parties to this proceeding and proceeded to have the jury hear the case. Prior to the presentation of evidence to the jury, Jellico confessed judgment as to Plaintiff’s breach of contract claim and \$236,750.50 in damages for the same. On March 5, 2020, the jury returned its verdict.

Pursuant to Jellico’s confessed judgment on the record before this Court and the jury’s verdict, it is, therefore,

ORDERED, ADJUDGED, AND DECREED that, PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. have judgment over and against DEFENDANT JELICO COMMUNITY HOSPITAL, INC. D/B/A JELICO COMMUNITY HOSPITAL HEALTH, LLC, in the amount of **\$236,750.50**.

It is further ORDERED, ADJUDGED, AND DECREED that, PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. have judgment over and against DEFENDANT COMMUNITY HOSPITAL CORPORATION, in the amount of **\$236,750.50** for the amount of actual damages awarded to Plaintiff by the jury.

It is further ORDERED, ADJUDGED, AND DECREED that, PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. have judgment over and against DEFENDANT JELICO COMMUNITY HOSPITAL, INC. D/B/A JELICO COMMUNITY HOSPITAL HEALTH, LLC, for pre-judgment interest in the amounts of **\$25,945.00** (8% interest calculated from January 30, 2019 thru June 12, 2020).

It is further ORDERED, ADJUDGED, AND DECREED that, PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. have judgment over and against DEFENDANT COMMUNITY HOSPITAL CORPORATION for pre-judgment interest in the amounts of **\$16,214.00** (5% interest calculated from January 30, 2019 thru June 12, 2020).

It is further ORDERED, ADJUDGED, AND DECREED that PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. have judgment over and against DEFENDANTS JELICO COMMUNITY HOSPITAL, INC. D/B/A JELICO COMMUNITY HOSPITAL HEALTH, LLC and COMMUNITY HOSPITAL CORPORATION, jointly and severally, for reasonable attorneys' fees and litigation costs of **\$160,386.50**.

It is further ORDERED, ADJUDGED, AND DECREED that PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. have judgment over and against DEFENDANTS JELICO COMMUNITY HOSPITAL, INC. D/B/A JELICO COMMUNITY HOSPITAL HEALTH, LLC and COMMUNITY HOSPITAL CORPORATION, jointly and severally, for costs of court in the amount of **\$2,559.75**.

It is further ORDERED, ADJUDGED, AND DECREED that PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. recover post-judgment interest at the rate of 8% per annum on all amounts awarded herein against DEFENDANT JELICO COMMUNITY HOSPITAL, INC. D/B/A JELICO COMMUNITY HOSPITAL HEALTH, LLC, compounded annually from the date of this judgment until paid.

It is further ORDERED, ADJUDGED, AND DECREED that PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. recover post-judgment interest at the rate of 5% per annum on all amounts awarded herein against DEFENDANT COMMUNITY HOSPITAL CORPORATION, compounded annually from the date of this judgment until paid.

It is further ORDERED, ADJUDGED, AND DECREED that, in the event of appeal to the 5th Court of Appeals, PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. recover reasonable and necessary attorneys' fees arising out of the appeal. Such costs and attorneys' in the amount of **\$35,000.00** is adjudged against DEFENDANTS JELICO COMMUNITY HOSPITAL, INC. D/B/A JELICO COMMUNITY HOSPITAL HEALTH, LLC and COMMUNITY HOSPITAL CORPORATION, jointly and severally, in the event of the unsuccessful appeal of this Final Judgment.

It is further ORDERED, ADJUDGED, AND DECREED that, in the event of appeal to the Texas Supreme, PLAINTIFF EMERGENCY STAFFING SOLUTIONS, INC. recover reasonable and necessary attorneys' fees arising out of the appeal. Such costs and attorneys' in the amount of **\$5,000** for the briefing stage and **\$10,000** for the oral argument is adjudged against DEFENDANTS JELLICO COMMUNITY HOSPITAL, INC. D/B/A JELLICO COMMUNITY HOSPITAL HEALTH, LLC and COMMUNITY HOSPITAL CORPORATION, jointly and severally, in the event of the unsuccessful appeal of this Final Judgment.

All writs and process for the enforcement and collection of this judgment and taxable costs of court may issue as necessary. All other relief not expressly granted in this judgment is denied.

THIS JUDGMENT IS FINAL AND APPEALABLE.
